

Friends of Medina County District Library Booze & Brews for Books Tour Raffle

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: Sweepstakes (the “Sweepstakes”) is open only to those who sign up at the sweepstakes page located at <http://www.friendsofmcdl.info/boozebrewsforbooks.html> and who are 21 years old as of the date of entry. The sweepstakes is only open to legal residents of the United States of America and is void where prohibited by law. Employees and volunteers of Friends of Medina County District Library (Friends of MCDL) their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

4. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Friends of MCDL. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is nontransferable. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 72 hours from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.
